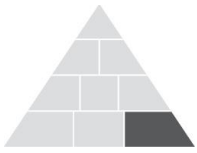

Information about Photo/Film Consent Form

What is the purpose of the Photo/Film Consent Form?

Queensland Rail is using the Photo/Film Consent Form (Form) to record your consent to Queensland Rail collecting, using and disclosing images or recordings of you and/or your children to promote Queensland Rail and/or describe its activities, on the terms set out in the Form

Why is Queensland Rail seeking my permission to collect, use and disclose images and recordings of me and/or the children?

A photographic image or recording of you comprises your personal information. Therefore, Queensland Rail must manage the images and/or recordings of you in accordance with the Information Privacy Act 2009 (Qld). Generally, Queensland Rail cannot use or disclose your personal information unless Queensland Rail makes you aware of the purpose for which the personal information is collected, and any entity to which Queensland Rail routinely discloses the personal information.

If Queensland Rail posts images and/or recordings of you on its website or a social media site, there is the potential for your personal information to be transferred outside of Australia. The Information Privacy Act 2009 (Qld) requires Queensland Rail to obtain your consent to transfer your personal information outside of Australia. If you sign the Form, you consent for this to occur.

How will Queensland Rail store the Photo/Film Consent Form and the images and/or recordings?

Queensland Rail stores the images and recordings of you, and the completed Form, digitally. Only authorised Queensland Rail staff have access to the images and recordings of you, and the completed Forms.

The Form and the images and recordings of you are public records. Therefore, Queensland Rail must retain the Form and images and recordings of you in accordance with the Public Records Act 2002 (Qld).

How will Queensland Rail use and disclose the images and recordings of me?

Queensland Rail will use images and recordings of you for the purposes set out in the Form. Because the purposes in the Form include public relations, promotions, commercial and advertising purposes, the typical places you might see images and/or recordings of you include:

- in a range of printed publications, such as brochures and magazines, to promote Queensland Rail's services;
- in advertisements promoting Queensland Rail's services, such as on billboards, or in third party publications;
- online – for example, on Queensland Rail's websites, or social media sites; and
- in television and video promotions of Queensland Rail's services.
